The deadline for the Call for Papers (Cases) for the 2020 Case Association Conference in Portland, Maine has been extended to Jan. 5, 2020.

The conference will take place May 13 – 16, 2020 in Portland, Maine at the Westin Harborview Hotel.

The CASE Association welcomes case writers from all disciplines and experience levels! CASE promotes the professional development of case writers.

#### Case topics can include:

Management, Strategy, Organizational Behavior/Development Human Resources, Business Ethics, Operations, Project Management, Accounting, Finance, Hospitality and Tourism, Entrepreneurship, Marketing, Others.

#### CASE invites you to submit:

- Embryo cases: A one-page outline of a case idea including a list of developmental issues for which the author seeks guidance (limit of one embryo submission per author MUST Use the Embryo Form on our website).
- Cases without an Instructor's Manual: Cases in development, authors will be assisted in preparing the teaching note.
- Cases with an Instructor's Manual: Case and Instructor's Manual sufficiently developed to facilitate constructive criticism in preparation for submission for publication.
- **Compact Cases** (3-5 pages in length): Provide a focused exploration of a real event, issue, or incident in a real organization. A full Instructor's Manual must be included.

## An update from Emerald

I wanted to share some information with you about The CASE Journal over the last year. We've had another great year and have published 38 case studies and articles on case writing. This is down to the hard work of Dr. Rebecca Morris as well as TCJ's team of reviewers who have all contributed to the fantastic content published in 2019.

We are also very excited to announce that TCJ was accepted into Scopus this year, which means that TCJ authors now publish in a globally esteemed publication. This endorsement of the quality of our content is an important step in being acknowledged as a valuable academic contribution.

Emerald continues to pay members of The CASE association \$100 upon publication of their case in TCJ. If the corresponding author is a member of the CASE Association at the time of publication, the corresponding author will be contacted and is eligible for a payment of \$100 from Emerald at the end of the calendar year.

Complementing our writing modules on the Emerald Cases Hub, we have just launched two new modules on 'Preparing to teach a case study' and 'Facilitating in the classroom.' Based on feedback from networks, we have incorporated information, guidance and examples of the issues most affecting faculty using cases: including enabling students to contribute, dealing with challenging classroom scenarios and ensuring everyone gets a chance to contribute.
